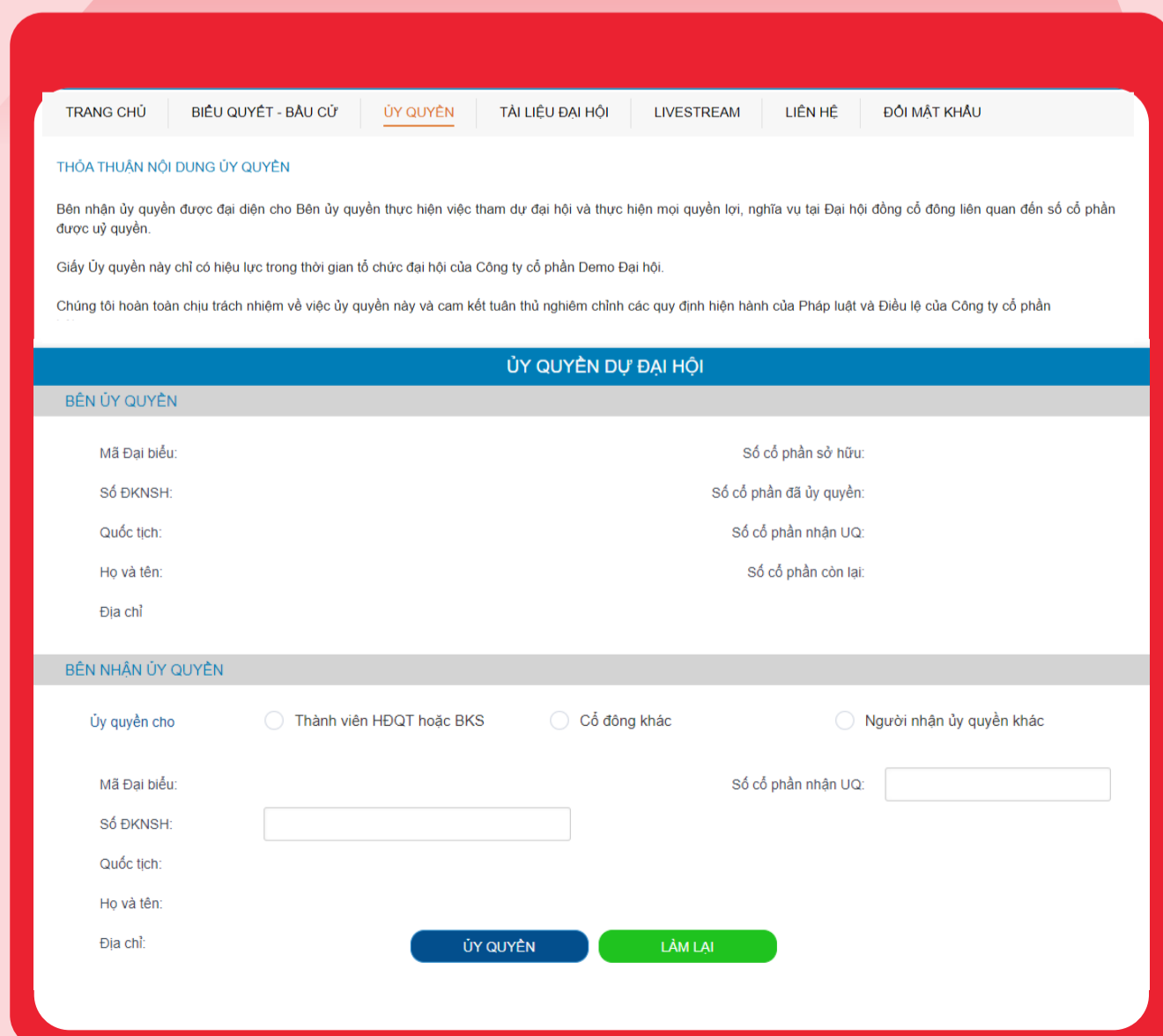


Shareholders exercise voting and election rights

2. Shareholders can authorize other shareholders or representatives to exercise the right to attend the Meeting on the system.

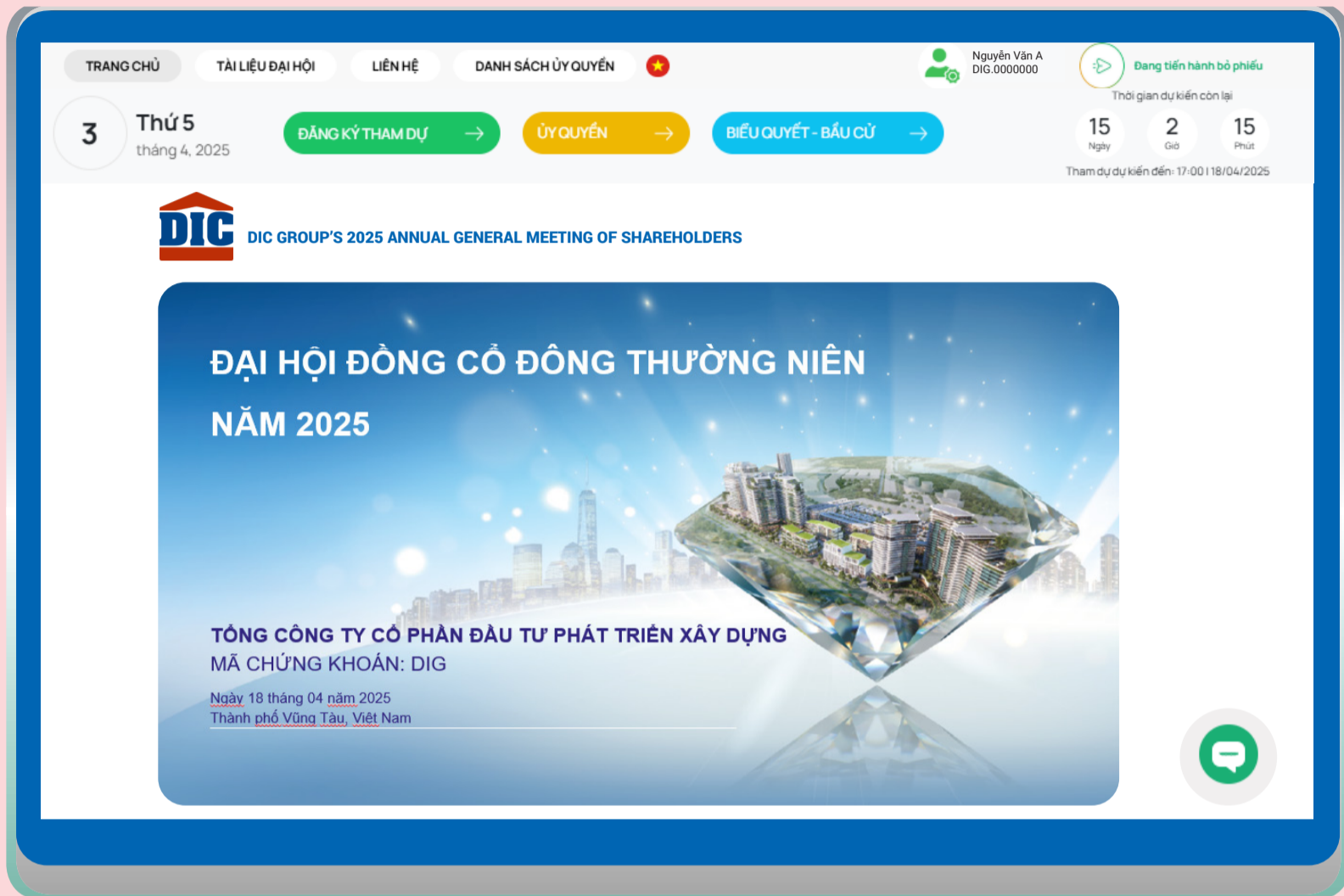

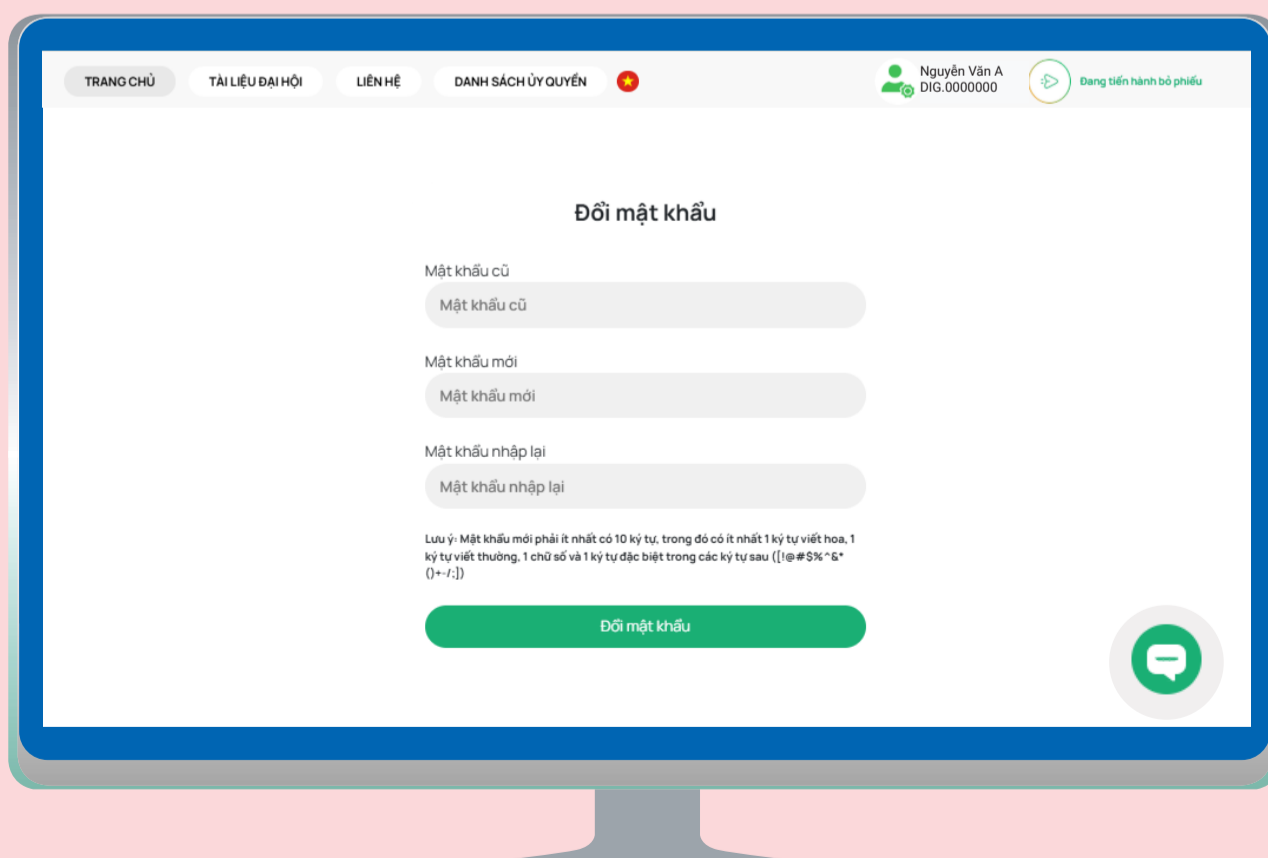
## LIVESTREAM
